Mayor Morgan called the meeting to order with a salute to the flag and in accordance with the Open Public Meetings Act by advertising notice of meeting in the N.J. Herald and posting copy of notice in the Borough Hall.

MUNICIPAL BUDGET REVIEW:

Tom Ferry the municipal auditor from FWCC attended this meeting to discuss the final budget information for consideration.

OFFICIALS REPORTS:

A Motion was made by Mr. Figueiredo, seconded by Mr. Smith to approve the Treasurer's Report for April 11th, 2016 as presented and waive the reading. Upon roll call the following votes were cast: AYES: Hoag, Figueiredo, Pearson, Smith, Delfing. NAYS: None. Motion carried.

REPORTS OF SPECIAL COMMITTEE: Mr. Landrith of the SWAC committee discussed the new latest solid waste laws. He also discussed the Water Quality 208 draft copy of the septic requirements that are being considered by the County.

Administrative & Executive:

Mr. Pearson reported that the Financial Disclosure Forms are due before the end of the month.

Celebration of Public Events:

Mr. Figueiredo / Mrs. Delfing reported that the Easter Egg Hunt went well and that the Memorial Day ceremony will begin at 10 a.m. on 5/30/16. The tree dedication for former Mayor Bollard will be held immediately following the Memorial Day ceremony. Sussex County Day is being planned and the Borough will participate.

Finance:

Mr. Dennison was absent and there was no report.

Parks & Playgrounds:

Mr. Figueiredo reported that the detectives looking into the graffiti determined it was not gang related. He also reported that a letter was sent to the resident who was riding their dirt bike in the park. Should it continue a summons will be issued.

Public Bldgs. & Grounds: Mr. Smith reported that the mowing is about to start at the parks. He will arrange to meet with the Memorial Park employee to discuss hours and have a certificate of insurance sent in by the person mowing Prospect Avenue. The boiler change out estimates will be available soon and the boiler can be purchased directly the Borough preventing mark up. The drapes in the park building should be removed and the floors need to be sealed or replaced.

Public Safety:

Mrs. Delfing reported that the ABFD would like the Borough to consider an ordinance naming the ABFD as primary rescue. This draft will be reviewed by the Borough Attorney and presented at next meeting. There was a brief discussion regarding the tenants and owner of 10 High Street in conflict with each other and harassing the members of the ABFD regarding the fire at that location in March. They should be referred to the municipal attorney. It was also mentioned that the ISO rating went has gone down.

Mrs. Delfing continued to report that the ABFD will be purchasing a 2003 Tahoe as a Chiefs Truck. The Borough will be responsible for maintenance of the vehicle.

A MOTION was made by Mrs. Delfing, seconded by Mr. Figueiredo to approve having the Tahoe added to the insurance policy. Upon roll call the following votes were cast: AYES: Figueiredo, Pearson, Smith, Delfing. NAYS: None. ABSTAIN: Hoag. Motion carried.

Streets & Roads:

Mr. Hoag reported that the catch basin on Lindley Court has been repaired and looks like a good job. There was some discussion regarding the no parking signs overnight or during snow removal in Newton and how that is the kind of sign we should order and install.

Water Utility:

Mr. Smith reported that the water system is good. There was a complaint from the Andover Hunt & Fish that they had bait die so the water was tested at the location and found to be good.

NEW BUSINESS:

In light of the recently received letter from the NJDOT approving a grant of \$145,000 to repair West High Street, the governing body discussed the funding that would be needed to complete that project. The Engineer will need to be consulted to determine how to proceed.

Annexation: The Mayor reported on the status of annexing certain properties to the Borough. A MOTION was made by Mr. Pearson, seconded by Mr. Smith to approve an amount of \$5000 to be budgeted to pay for professional services pursue this possibility. The Mayor mentioned that the County has hired a new business administrator and road works supervisor. He will be meeting with them in the near future regarding the shared service agreement.
