DIMENSIONAL REGULATIONS", OF CHAPTER 134, ENTITLED "ZONING", OF THE
CODE OF THE BOROUGH OF ANDOVER, COUNTY OF SUSSEX, STATE OF NEW
JERSEY." The ordinance amends the bulk requirement portion of the code book to alert
zoning officials that there is a different setback for Cannabis Use. Upon roll call the
